





# Crime Prevention Through Sport Fund

CRITERIA, GUIDANCE AND APPLICATION FORM

### <u>Introduction</u>

The Crime Prevention Through Sport Fund aims to support projects that use sport and physical activity to reduce violence, crime and anti-social behaviour. This fund is for projects that focus on using activity as a tool to engage and support young people up to the age of 25. Applications that use sport in its widest sense including traditional, informal sports and activities will be considered and encouraged to apply.

# Eligibility

- Organisations including constituted sports clubs, charities, voluntary or community groups and education establishments can apply
- Sole traders or individuals are ineligible for funding
- Location of delivery must take place within the Avon & Somerset Constabulary area covering Bath & North East Somerset, Bristol, North Somerset, Somerset and South Gloucestershire.
- Funding cannot be used for capital works projects i.e. refurbishment of facilities or building works, small equipment costs will be eligible when directly related to the project.

## **Timeframe & Awards**

Two submission rounds will be open in 2021 for projects to apply and complete delivery by March 2022.

# Phase 1 – February 2021

- Applications will open on Monday 8<sup>th</sup> February 2021
- Remaining open for 6 weeks closing on Monday 22<sup>nd</sup> March 2021 12 noon

A panel made up of Avon & Somerset Constabulary colleagues, Office for Police and Crime Commissioner and Active Partnerships will meet in March to award grants.

# Phase 2 - April 2021

- Applications will open on Monday 5<sup>th</sup> April 2021
- Remaining open for 6 weeks closing on Monday 17<sup>th</sup> May 2021 12 noon
- Another panel meeting will determine eligible awards in June 2021.

Awards will be granted by Wesport / SASP who will prepare a partnership agreement, manage invoices and request reporting to support the monitoring, evaluation and learning from the fund.

# Guidance and Criteria for Funding

For most young people, offending is transitory but for a small group of young people this behaviour can be ingrained and pervasive. There is a lack of consensus about the reasons for offending but the link with Adverse Childhood Experiences (ACEs) is increasingly seen as significant.

Please use these areas as a reference point for your application, these will form the criteria used when assessing your application for funding.

1.	Right Staff	Focus on young people as well as on sport / activity. Have authority but are not authoritative. Staff (and volunteers) operate as role models and mentors, building long term relationships with young people. Act as catalysts for change in young people's lives. 2.	Right Young People		How do you access these participants?
3.	Right Style and Right Place	Needs-based and accessible delivery. Environment that feels safe to young people.  Based on clear understanding of the needs of the targeted young people (e.g. age, gender, ethnicity, problem behaviour).	Where do you plan to deliver?
4.	Rewards/Rewarding activities	Retention of young people is aided by	What reward structure can be considered alongside your project?
5.	Attractive offer	Engaging, high quality offer (e.g. Enjoyable, challenging, energetic, varied). Organic and flexible to change over time. Recognises the dynamic process between the participant and the programme.	What's your key selling point?

# 'The Structure of the intervention' – Five Key Characteristics

	Criteria Area	Outline	Is this referenced with the application?
6.	Clear Ethos	Mutual respect. Relationships based on trust, respect, fairness, voluntarism/choice. Sense of community.	
7.	Sustained Delivery	Interrupted delivery impacts negatively on young people's attendance. Ongoing, open-ended delivery (or identified and accessible exit routes identified) encourages long term retention.	
8.	Multi-agent/ Partnerships	Increases chance of engaging the 'right' young people (i.e. those the project is intended to impact on) Can build trust between young people and institutions such as schools/colleges and the police and facilitate the improvement of young people's skills, qualifications and behaviours. Partnerships can also enhance access to stable resources in order to sustain delivery.	
9.	Personal development opportunities	Can be formal or informal opportunities. Focus on self-esteem, locus of control and cognitive skills that enable young people to take on greater challenges. Also a clear focus on health, welfare and education.	
10.	Positive Pathway	Provide opportunities for young people to adopt a positive direction in their life. Pathway to health/work.
